GIVING THROUGH THE PASS SYSTEM

(Personal Access Self Service)

LOGON TO PASS at my.uh.edu/PASS.

CLICK ON Payroll Taxes and Salary.

CHOOSE Voluntary deductions.

CLICK ON the magnifying glass to the right of the type of deduction to choose the fund you wish to contribute to.

CLICK ON the UH contribution of your choice.

CHOOSE whether you want a flat amount or a percentage of your gross pay to be deducted.

ENTER either the flat dollar amount or the percentage of your gross pay you are contributing. This deduction will be taken the first pay period of every month.

TYPE IN the goal amount, which is the total dollar amount of your pledge for the entire period. When the goal amount has been reached the deduction will stop automatically.

ENTER THE DATE you want your deduction to begin.

ENTER THE DATE you want your deduction to stop.
